## **Text Message Authorization**

**TEXT MESSAGE ALERTS:** As a courtesy, the Cuyahoga County Probate Court can send text message alerts when hearings or appointments are set, as well as information and reminders about your case. This includes emergency closing notifications. Text message alerts are in addition to and do not replace other notifications sent by the Court. The Court encourages all persons with a pending case in the Probate Court to opt-in to this service.

**SUMMARY TERMS & CONDITIONS:** Mobile text message alerts are intended for individuals with business with the Cuyahoga County Probate Court and are delivered via USA toll free number (888) 689-9997. You may receive multiple text messages per month depending on the activity in your case(s).

**MESSAGE & DATA RATES MAY APPLY:** The service is available to persons with text capable phones subscribing to various carriers including, but not limited to AT&T, Verizon Wireless, T-Mobile, Sprint, Virgin Mobile USA, Cincinnati Bell, Centennial Wireless, Unicel, U.S. Cellular, and Boost. You can stop receiving text message alerts at any time by texting <u>STOP</u> to toll free number (888) 689-9997. To opt back in, text <u>UNSTOP</u> to toll free number (888) 689-9997.
